

Use of Cookies

In order to ensure full functionality and security of the website of AS Signet Bank (hereinafter – the Bank), as well as to adapt it to your usage habits, we use cookies.

The Bank uses various types of cookies, from which cookies necessary for the operation of the website are placed by default, but we ask for your consent for cookies used for analytical purposes. By giving this consent in the cookie bar displayed during your visit to the website, you can choose whether to use certain types of cookies.

What are cookies?

Cookies are small text files that the web browser stores on the user's computer, mobile phone (or tablet) when you open the website. They identify the browser or the information stored in the browser or the settings that are chosen to view the site (such as language settings) so that they do not have to be re-specified each time. Thus, with the help of cookies, the website acquires the ability to store the user's individual settings, recognize him or her and respond accordingly. The use of cookies can be disabled or limited, but without cookies it will not be possible to fully use all the functions of the website.

Depending on the functions and purpose to be performed, we use the following cookies:

Strictly necessary cookies

Cookies are necessary for you to freely visit and browse the website and use the features it offers. These cookies identify your device, but do not disclose your identity, nor do they collect or collect information. Without these cookies, the website cannot function properly.

Functional cookies

With functional cookies, the website remembers the selected settings and other personalized preferences so that later this website is more convenient to use.

Analytical cookies

Analytical cookies collect information about the use of the website and detect the most frequently visited sections, including the content you choose when browsing the website. The information is used for analytical purposes in aggregate form in order to find out what interests the users of the site, so that the functionality of the page can be improved and made more convenient to use.

Marketing cookies

These cookies are set by other companies whose functionality is used by the website. Cookies are used to identify the content you want and provide the most relevant information about products and services, while in case of refusal, general and non-personalized ads may be offered.

ga*	Google Analytic cookie that saves the count of saved pages.	1 year, 1 month, 4 days	analytical
<u>ga</u>	This cookie is used to recognize separate users by assigning unique identifiers. These identifiers are used in the request section of the page to provide descriptive analysis of the site's visits and sessions.	1 year, 1 month, 4 days	analytical
_gid	Google Analytic cookie that provides information on habits of usage of the site's users and gathers descriptive analysis on the site's capacities.	1 day	analytical
_gcl_au	This cookie is used to store information on the usage of the site and helps gather descriptive information on the functionality of the site.	4 months	analytical
ajs_user_id	This cookie gathers information on the user's experience on the site and uses	1 year	analytical

Information about the choice of cookies.

When visiting the Bank's home page, a window is displayed with a notification that cookies are used on the website. If you choose the option "AGREE", it means that you have agreed to all cookies contained on the website and at the same time confirm that you have read the cookie usage information.

Mandatory cookies do not require consent, as they ensure the completeness of the website and the continuous display of the content so that you can receive an appropriate digital browsing experience.

If you want cookies not to be used on your device, you can manage, restrict or prohibit the use and storage of cookies on your devices, or delete cookies that have already been stored.
