What is this product?

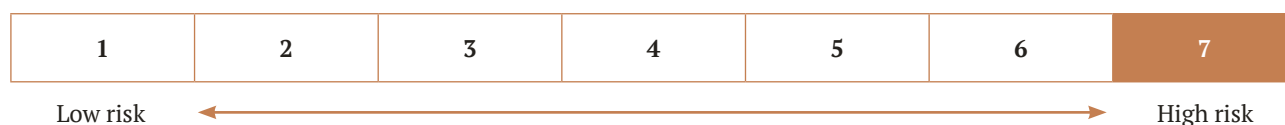
Type	An Over the Counter Derivative (OTC) contract – Foreign Exchange Swap Instrument
Objectives	<ul style="list-style-type: none">• The objective of this product is to perform two currency exchanges in opposite directions on two agreed dates (start date and maturity date). In the currency exchanges agreed amounts of one currency are exchanged for another currency at agreed exchange rates. It may be used as a protection against adverse changes in exchange rates.• The product achieves its objective by you and Signet Bank agreeing to the terms of the FX Swap under which (1) you agree to pay Signet Bank an agreed amount in one currency (Ccy1) and Signet Bank agrees to pay you an agreed amount in another currency (Ccy2) on the start date and (2) Signet Bank agrees to pay you the agreed amount in Ccy1 and you agree to pay to Signet Bank the agreed amount in Ccy2 on the maturity date.• Payments under an FX Swap consist of the agreed amounts in the two currencies (Ccy1 and Ccy2) which are based on the agreed exchange rate and forward points.• The forward points are based on the difference in interest rates in both currencies for the maturity date of the product.• The market value of the FX Swap is exposed to changes in the current exchange rate between the two currencies and changes in the market interest rates in both currencies for the time to maturity of the product.• The expiry date of the FX Swap will be set out in the confirmation for the product. The FX Swap is a bilateral agreement that cannot ordinarily be terminated unilaterally by either you or Signet Bank. It is a product that is entered into for its term, although early termination may occur in the event of a default of either you or Signet Bank. The agreement between you and Signet Bank provides that if certain exceptional events occur (1) Signet Bank may make adjustments to certain products and/or (2) Signet Bank or you may terminate the product early. These events are specified in more detail in the agreement between you and Signet Bank. The product may also be terminated upon mutual agreement. The amount (if any) you receive or pay on such early termination is likely to be different from the scenarios described in this document.

- You may not be able to terminate this product even though you or Signet Bank have terminated or discontinued a product or a commercial flow that this product is aimed to hedge.
- Illustrative terms are set out below, which are illustrative of the terms of an FX Swap, but which do not reflect the exact terms you agree with Signet Bank. The exact terms will be set out in an individual trade confirmation.

What are the risks and what could I get in return?



The summary risk indicator is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. We have classified this product as 7 out of 7, which is the highest risk class. **Be aware of currency risk. You will receive payment in a different currency, so the final return you will get depends on the exchange rate between the two currencies. This risk is not considered in the indicator shown above.** This rates the potential losses from future performance at a very high level, and poor market conditions are very unlikely to impact the capacity of Signet Bank to pay you.

When this product is combined with other products or commercial positions, the total portfolio will have a different net risk profile. This product does not include any protection from future market performance so you could lose some or all of your investment. If we are not able to pay you what is owed, you could lose your entire investment.
